#### **About**

Poonam has been actively involved in the disputes and corporate practice of the firm with primary focus in the Energy and Transportation Sector. For around two decades with the firm, Poonam has specialized in Power and Aviation Sectors. She has been regularly representing the country's big corporate houses, government institutions and industry associations on several landmark and sectoral issues arising in the two sectors, for instance, issues arising out of Power Purchase Agreements, Concession Agreements, Transmission Service Agreements, Operations, Maintenance and Development Agreement and State Support Agreement based on Model Private Public Partnership (PPP) Agreements issued by the concerned Ministries of the Government of India.

Poonam has a lead role in the Aviation part of the infrastructure practice of the firm. She has been instrumental in spearheading the Civil Aviation practice. She has been consistently advising and representing Federation of Indian Airlines, International Air Transport Association amongst individual airlines on legislative, policy and regulatory issues. She represents the clients before various fora (Airports Economic Regulatory Authority of India, the Director General of Civil Aviation, the Appellate Tribunal, the High Courts and Supreme Court) on issues relating to interpretation of agreements executed pursuant to PPP tendering processes, determination of aeronautical tariff, single till and other charges being levied by the Airport Regulator on Airlines.

She has submitted her views from time to time on the Model Concession Agreements issued by the Ministry of Civil Aviation for introducing PPP for six airports, on National Civil Aviation Policy, Civil Aviation Authority Bill etc. Poonam has been consulted on urgent issues by International Air Transport Association and Federation of Indian Airlines, Association of Power Producers on several occasions for legal opinions.

Poonam is a regular participant and speaker in nationwide conferences conducted from time to time by Centre for Aviation, Federation of Indian Chambers of Commerce and Industry, the Confederation of Indian Industry on energy and aviation sector related issues.

She has been practicing law since 2004. Before joining JSA, she worked with Chambers of Mr. Amarjit Singh Chandhiok, Senior Advocate and ex-President of the Delhi High Court Bar Association for two years.

## **Experience**

Some of the key assignments in these areas handled and being handled by Poonam amongst others, cover the following: -

## **Energy**

- Successfully represented **Adani Power Rajasthan Limited** in a matter involving high-stake issues impacting the sector. Issues involved interpretation of Inter-Plant to reduce unwarranted litigation and ensure timely payment of dues to power generators. The Supreme Court recognized the concept of time value for money for the power sector.
- Successfully represented **Rain CII Carbon (Vizag) Limited**, a leading Indian calciner in India. The matter involved a unique environmental law proposition regarding applicability of import limits of Raw Petroleum Coke ("**RPC**") and Calcined Petroleum Coke ("**CPC**") in case when import is proposed solely for re-export purposes. This issue also required understanding of Flue Gas Desulfurization ("**FGD**") system and its impact on the environment and an interpretation of the SEZ law and foreign trade policy.
- Represented **Rain CII Carbon (Vizag) Limited** in the matter related to challenging the levy of Grid Support Charges on Co-Generation Plants.
- Represented Adani Power Limited, a power generating company having installed capacity of 4,620 MW in a landmark case starting from the lowest forum (CERC) to the highest forum (Supreme Court). For the first time, the Supreme Court adjudicated upon the regulatory intervention and the principles governing contract readjustments in competitively bid out long term Power Purchase Agreements. The underlying issue was treatment of adverse, unforeseen and uncontrollable events which destroyed the economic substratum of long term Power Purchase Agreements which are inherently incomplete in nature. This provides clarity on long outstanding issue of import of coal and sustainability of power plants.
- Successfully represented Parampujya Solar Energy Private Limited on the issue whether the Solar
  Power Producers are required to be restituted under the Change in law provision in the PPA or not?
  In a first of its kind judgment, APTEL has principally recognised that claim for Carrying Cost being
  the cost incurred by the Solar Power Developer to arrange for the additional payment/cost to be

incurred on account of a Change in Law event. This is the **first judgment** wherein restitutive provision was interpreted in favour of the RE developers.

- Successfully represented **Kamuthi Solar Power Limited and Ramnad Renewable Energy Limited**. The judgement recognizes readiness of the projects and has granted relief for a full term of 25 years. It not only settles the six year long brawl for tariff recovery, but also throws light on some key issues on connectivity approvals etc.
- Successfully represented Warora-Kurnool Transmission Limited in getting approval of CERC to transfer the shares and management control of WKTL in favour of the nominee of WKTL's lenders. This is the first order, wherein CERC has interpreted the 'equity lock-in' clause and 'Lender's right to substitution' clause of a standard Transmission Service Agreement executed by transmission licensees under tariff bases competitive bidding process.
- Successfully represented NERES XVI Power Transmission Limited in obtaining Transmission
  License for development and operation of Inter-State Transmission System under the
  'Transmission Scheme for North-Eastern Region Expansion Scheme-XVI', and adoption of
  Transmission Tariff for the same discovered through Tariff Based Competitive Bidding.
- Successfully represented **SEPC Power Private Limited**, an imported coal based thermal power plant located at Tuticorin, regarding its claim for fixed charges for the period of non-operation. It involved the issue of supply of power under Section 11 of the Electricity Act, 2003. SEPC sought compensation for difference in actual cost of generation and the cost being paid by Discom as per the benchmark rates determined by Ministry of Power's Committee.
- Successfully represented UltraTech Cement Limited in obtaining relief before Hon'ble Karnataka
  High Court against Mangalore Electricity Supply Company Limited's Demand & Disconnection
  Notices served upon UTCL's Bulk Terminal, i.e. cement packing unit, seeking back billing charges and
  differential arrears over MESCOM's unilateral categorization of the Bulk Terminal as 'commercial'
  consumer.
- Advised M/s. PPN Power Generating Company Private Limited, a gas-based power plant situated at Pillaiperumalnallur, Tamil Nadu, regarding its entitlement for seeking specific performance of contract from GAIL for supplying full quantity of natural gas to PPN under the Gas Sales and Purchase Contract.
- Represented **Tata Power Company Limited** on regular basis in matters relating to generation and distribution businesses, more particularly on the issue of parallel licensing in distribution business in Mumbai.
